WRIT OF ELECTIONS

Elizabeth The Second, by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of Our other Realms and Territories Queen, Head of the Commonwealth, Defender of the Faith.

To the Returning Officer of the electoral district of Montserrat:

WHEREAS by section 20 (1) of the Elections Act (Cap. 1.04), it is provided that for the purpose of every general election of members of the Assembly, and for the purpose of the election of members to supply vacancies caused by death, resignation or otherwise, the Governor shall issue writs of election under the Public Seal of Montserrat, addressed to the Returning Officer;

AND WHEREAS the seat of an elected member has become vacant in consequence of the resignation of the Leader of the Opposition, Mr. Reuben T. Meade;

NOW, THEREFORE, I, **Elizabeth Carriere**, Governor of Montserrat do hereby require that you proceed to the nomination of candidates on the **17th day of January, 2017**, at the St. Patrick's Co-Operative Credit Union Hall, Brades, MSR1110, Montserrat and thereafter, if necessary, you do on the **30th day of January, 2017** between the hours of 7 a.m. and 6 p.m., cause election to be made according to law of a member to serve in the Legislative Assembly of Montserrat and that you do cause the name of the member when so elected to be certified to me not later than the **1st day of February, 2017** and in the year of Her Majesty's reign.
