Will it apply throughout the duration of the contract?	Withholding tax applies to the gross amount received by the Non-resident entity. This would be deducted as funds are disbursed throughout the contract.
2. Will Non-resident companies be required to register with the Inland Revenue Department of the Montserrat Customs and Revenue Service? a. Will non-resident companies be required to file annual return with the Inland Revenue Department of the Montserrat Customs and Revenue Service?	 2. The Non-resident entity would need to be registered as an employer if the company employs persons. The employer would be required to deduct PAYE from the salaries and wages paid to employees. a) The Non-resident entity is not required to file a tax return. The deduction is final.
3. Please confirm in C5.2(IV) reference to "Payment Bond" is intended to mean Advance Payment Bond, and if so, can you provide specimens of both the Performance and Advance Payment Bonds.	3.
