AN ACT TO SANCTION CERTAIN PAYMENTS FROM THE CONSOLIDATED FUND IN EXCESS OF THE SUMS PROVIDED BY LAW FOR THE SERVICES OF THE GOVERNMENT OF MONTSERRAT FOR THE PERIOD ENDING ON THE THIRTY-FIRST DAY OF MARCH, 2019.

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Montserrat, and by the Authority of the same as follows:—

1 Short title

This Act may be cited as the Supplementary Appropriation (No. 2) Act, 2019.

2 Authorisation of expenditure

- (1) The sum authorised in subsection (2) is in addition to the sum of one hundred and thirty-one million, nine hundred and sixty-four thousand seven hundred dollars (\$131,964,700) granted by the Appropriation Act 2018 (No. 3 of 2018) and the Supplementary Appropriation Act 2019 (No. 1 of 2019) for the period ending on 31 March, 2019.
- (2) The sum totalling seven hundred and seventy-three thousand nine hundred dollars (\$773,900) is authorised to be issued from the Consolidated Fund and expended for the services set out in the Schedule.

3 Payments

The Accountant General is authorised and required from time to time, upon the authority of warrants of the Minister of Finance, to pay the sums appropriated to the services set out in the Schedule as the warrants may direct out of the Consolidated Fund without further order or formality.
