# ADMINISTRATIVE COST RECOVERY PROVISION ACT

AN ACT TO PROVIDE FOR THE RECOVERY OF ADMINISTRATIVE COST OR EXPENSES IN RESPECT OF CERTAIN MATTERS AND FOR MATTERS CONNECTED THEREWITH OR INCIDENTAL THERETO.

#### Commencement

[17 June 1994]

#### Short title

**1.** This Act may be cited as the Administrative Cost Recovery Provision Act.

## Collection or recovery of administrative expenses

2. There shall be collected or recovered administrative cost incurred or to be incurred in respect of the several matters set out in Column 1 of the Schedule to this Act at the rate specified in Column 2 by the persons specified in the corresponding entry in Column 3 of the Schedule thereto and paid to the Consolidated Fund.

# Price to be marked for all publications

- **3. (1)** Every publication of the Government intended for sale shall be marked with the price on the cover of such publication and all proceeds of sale properly accounted for and receipt issued for all sales.
- (2) It shall be the duty of all Heads of Departments to ensure that all proceeds of sales are regularly paid to the Accountant General to be credited to the Consolidated Fund.
- (3) The price shall be determined by the Head of Department in consultation with the Accountant General having regard to the cost incurred in printing.

# Governor acting on the advice of Cabinet may amend the Schedule by Order

**4.** The Governor acting on the advice of Cabinet may by Order amend the schedule to section 2 but no such order shall have effect unless approved by Resolution of the Legislative Assembly.

# Interpretation

**5.** In this Act unless the context otherwise requires the expression "Administrative Cost" shall include "printing cost".
