THE CUSTOMS DUTIES AND CONSUMPTION TAX (COVID-19 PERSONAL PROTECTIVE ITEMS) (EXEMPTION) ORDER 2020 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Covid-19 Personal Protective Items) (Exemption) Order, 2020.

2. Exemption

A person who imports an item described in the Schedule is exempted from the payment of customs duty, consumption tax and processing fee on the importation of the item.

3. Expiration

This order expires 15 July, 2020.
