(CYNTHIA BOLDEN) (EXEMPTION) ORDER

THE CUSTOMS DUTIES AND CONSUMPTION TAX (CYNTHIA BOLDEN) ORDER 2020 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Cynthia Bolden) (Exemption) Order, 2020.

2. Exemption

- (1) Subject to paragraph 3, Cynthia Bolden is exempted from the payment of Customs Duty and Consumption Tax on the importation of the items described in the Schedule.
- (2) The exemption in subparagraph (1) applies if the items are imported by 31 December 2020.

3. Conditions

- (1) The items imported under paragraph 2 must be—
 - (a) addressed to Cynthia Bolden and imported by Cynthia Bolden; and
 - (b) used in the construction and furnishing of the building to be built on Block 12/01 Parcel 144.
- (2) Cynthia Bolden shall—
 - (a) keep a current and detailed record on the use of the items exempted under paragraph 2; and

- (b) permit the Comptroller of Customs and Excise or a person authorised by him to—
- (i) inspect the record referred to in subparagraph (2)(a); and
 - (ii) access the building in order to determine compliance with the conditions in subparagraphs (1) and (2)(a).
- (3) If Cynthia Bolden contravenes subparagraphs (1) and (2), she shall pay to the Comptroller of Customs and Excise the customs duties and consumption tax exempted under paragraph 2.
