REVISED EDITION OF LAWS ORDER 2020

THE REVISED EDITION OF LAWS ORDER 2020 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 10 OF THE REVISED EDITION OF LAWS ACT (CAP. 1.03).

1. Citation

This Order may be cited as the Revised Edition of Laws Order, 2020.

2. Interpretation

In this Order—

“**Act**” means the Revised Edition of Laws Act (Cap. 1.03) (Cap. 1.03);

“**revised booklet**” includes booklets stored on a CD ROM or another electronic format; and

“**revision date**” means the date up until which the revised edition is current, showing the laws as amended and in force on that date.

3. Revised edition in force

(1) The 2019 Revised Edition of the Laws of Montserrat, described in paragraph 4, comes into force as the sole authentic edition and authoritative version of the laws of Montserrat on 15 February 2020.

(2) The revision date for the 2019 Revised Edition of the Laws of Montserrat is 1 January 2019.

4. Description of the Revised Edition

- (1) The 2019 Revised Edition of the Laws of Montserrat was prepared by revised booklets under section 5 of the Act and contains all the Acts and related subsidiary legislation at the revision date, other than omitted laws, in one hundred and one bound booklets.
- (2) The laws of Montserrat contained in the revised booklets of the 2019 Revised Edition of the Laws of Montserrat are set out in the Schedule.
