**PUBLIC HEALTH (COVID-19 SUPPRESSION) (NO.4) (AMENDMENT) ORDER**

**THE PUBLIC HEALTH (COVID-19 SUPPRESSION) (NO. 4) (AMENDMENT) ORDER 2020 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 10 OF THE PUBLIC HEALTH ACT (CAP. 14.01).**

**1. Citation and commencement**

This Order may be cited as the Public Health (Covid-19 Suppression) (No.4) (Amendment) Order, 2020 and comes into force 4 August, 2020 at 5 a.m.

**2. Interpretation**

In this Order “**principal Order**” means the Public Health (COVID-19 Suppression) (No.4) Order, 2020 (SRO. 44 of 2020).

**3. Paragraph 2 amended**

Paragraph 2 of the principal Order is amended by inserting the following into the correct alphabetical order—

““**professional person**” means a person whose job requires a minimum of two years training or work experience and whose job is not of a temporary or seasonal nature;”

**4. Insertion of paragraph 3A**

The principal Order is amended by inserting the following as paragraph 3A—

“**Mandatory face covering**

**3A.** (1) A customer or visitor shall wear a face covering when entering and while conducting business in following places—

(a) a bank;

- (b)* a Government office;
  - (c)* a hospital;
  - (d)* a clinic or health centre;
  - (f)* a grocery store or supermarket; and
  - (e)* any other place of business.
- (2) Subparagraph (1) does not apply to the following—
  - (a)* a child age 3 years and under;
  - (b)* a person who has a medical condition, health condition, cognitive condition or disability that prevents the person from wearing a face covering;
  - (c)* a customer, when the customer is dining at a restaurant or food shop;
  - (d)* a customer, when the customer is drinking at a bar or rum shop; and
  - (e)* a person when the person is exercising in a gym.
- (3) A face covering should cover a person’s nose, mouth and chin without gapping.”

**5. Paragraph 5 amended**

Paragraph 5(2) of the principal Order is amended by—

- (a) deleting sub-subparagraph *(e)* and inserting the following—
  - “*(e)* the husband, wife, child or other dependant of a person who falls under subparagraph *(a)*, *(b)*, *(c)* or *(d)* whether travelling with or separately from the person, provided that the husband, wife, child or other dependant of a person resided in Montserrat, for any period of time, prior to 16 March, 2020;”
- (b) inserting the following as sub-subparagraph *(fa)*:
  - “*(fa)* a professional person who has been engaged by the Government of Montserrat, provided that he has been

granted permission by the Minister to disembark in Montserrat prior to travelling to Montserrat;”.

**6. Paragraph 23 amended**

Paragraph 23 is deleted and substituted by the following:

**“Expiry**

**23.** This Order expires 30 August, 2020 at 5 a.m.”
