THE COMPANIES (AMENDMENT) REGULATIONS, 2014 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 527 OF THE COMPANIES ACT (CAP. 11.12).

1. Citation and commencement

These Regulations may be cited as the Companies (Amendment) Regulations 2014 and shall come into force on the 1st day of March, 2014.

2. Regulation 27 substituted

Regulation 27 of the Companies Regulations (Cap 11.12) is repealed and the following is substituted—

(2) The fees payable in respect of a non-profit company shall, in *lieu* of the fees payable under paragraph 1(a) to (p), be 20% of the fees payable under paragraph 1(a) to (p).

- (3) The Registrar may waive—
 - (i) a fee payable under paragraph 1(c) or (o);
 - (*ii*) a late fee accruing for default in filing annual returns.

(4) If a fee is paid in respect of any application for exemption and the application is registered, withdrawn or abandoned, no part of the fee is returnable.
