ROAD TRAFFIC (AMENDMENT) REGULATIONS 2018

THE ROAD TRAFFIC (AMENDMENT) REGULATIONS 2018 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 78(1) OF THE ROAD TRAFFIC ACT (CAP. 7.06).

1. Citation

These Regulations may be cited as the Road Traffic (Amendment) Regulations, 2018.

2. Interpretation

In these Regulations, "**principal Regulations**" means the Road Traffic Regulations (Cap. 7.06).

3. Regulation 19 amended

Regulation 19(1) of the principal Regulations is deleted and the following is substituted—

"Sign or poster on windscreen or window of a motor vehicle

- 19. (1) Subject to this regulation and regulation 18, a person shall not drive on a road a motor vehicle with a sign or poster on the front windscreen, the rear windscreen, a front side window or a rear side window other than a sign or poster required by law.
 - (2) Despite subregulation (1), a person may apply in writing to the Licensing Officer for approval to affix a sign or poster to—
 - (a) the front windscreen or rear windscreen of a motor vehicle; or
 - (b) a rear side window of a motor vehicle that has four or more side windows.

- (3) For the purposes of subregulation (2)(b), a sign or poster may only be affixed to a side window nearest the rear windscreen.
- (4) An application under subregulation (2) shall—
 - (a) specify the motor vehicle to which the sign or poster is to be affixed;
 - (b) specify the intended location of the sign or poster on the motor vehicle; and
 - (c) be accompanied by a sample of the sign or poster to be affixed to the motor vehicle.
- (5) The Licensing Officer shall notify a person of the approval or otherwise of his application under subregulation (2).
- (6) The Licensing Officer shall not approve a sign or poster that contains a word, phrase or image that is obscene or indecent.
- (7) A transparent sign or poster that is affixed to—
 - (a) a front windscreen shall not exceed ten inches in length, measured from the top edge of the windscreen and may be of any width; or
 - (b) a rear windscreen or a rear side window may be of any measurement.
- (8) A sign or poster that is not transparent and is affixed to—
 - (a) a front windscreen shall not exceed six inches in length, measured from the top edge of the windscreen and may be of any width;
 - (b) a rear windscreen shall not exceed four inches measured from the edge of one side of the windscreen only; or
 - (c) a rear side window shall not exceed eleven inches in length and eight inches in width.
- (9) If a transparent sign or poster is affixed to the front windscreen, rear windscreen or a rear side window of a motor vehicle, the degree of visual

transmission of light shall be in accordance with regulation 18.

(10) Subregulation (1) does not apply to a quarter glass.".
