CUSTOMS DUTIES AND CONSUMPTION TAX (ALOE MONTSERRAT COMPANY LIMITED) (EXEMPTION) ORDER

THE CUSTOMS DUTIES AND CONSUMPTION TAX (ALOE MONTSERRAT COMPANY LIMITED) (EXEMPTION) ORDER 2018 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Aloe Montserrat Company Limited) (Exemption) Order, 2018.

2. Exemption

Aloe Montserrat Company Limited is exempted from the payment of customs duty and consumption tax on the importation of—

- (a) the items listed in the Schedule; and
- (b) a maximum of six motor vehicles.

3. Conditions

- (1) The items imported under paragraph 2(a) must be imported within three years from the date this Order comes into force.
- (2) The motor vehicles imported under paragraph 2(b) must be—
 - (a) imported within five years from the date this Order comes into force; and
 - (b) used for the sole purpose of carrying out the business of Aloe Montserrat Company Limited.
