THE CUSTOMS DUTIES AND CONSUMPTION TAX (DAVID LEA AND CLOVER LEA) (EXEMPTION) ORDER 2017 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (David Lea and Clover Lea) (Exemption) Order, 2017.

2. Exemption

David Lea and Clover Lea, trading as Gingerbread Hill, are exempted from the payment of customs duties and consumption tax on the importation of the items listed in the Schedule.

3. Condition

The exemption granted under paragraph 2 expires on 7 March, 2018.
