**THE CUSTOMS DUTIES AND CONSUMPTION TAX (MONTserrat FOOTBALL ASSOCIATION INC.) (EXEMPTION) ORDER 2018 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).**

**1. Citation**

This Order may be cited as the Customs Duties and Consumption Tax (Montserrat Football Association Inc.) (Exemption) Order, 2018.

**2. Exemption**

Montserrat Football Association Inc. is exempted from the payment of customs duty and consumption tax on the importation of items imported during the period 2016 to 2017 as listed in the Schedule.
