THE CUSTOMS DUTIES AND CONSUMPTION TAX (B.B.C RADIO AND TV LTD) (EXEMPTION) ORDER 2018 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (B.B.C Radio and Tv Ltd.) (Exemption) Order, 2018.

2. Exemptions

B.B.C Radio and Tv Ltd. is exempted from the payment of —

- (a) Customs Duty and Consumption Tax on the importation of the items listed in the Schedule 1.
- (b) Customs Duty on the importation of the items listed in the Schedule 2.

3. Conditions

- (1) The racks and shelves imported under paragraph 2 (a) must be used for the sole purpose of furnishing the department store extension owned by B.B.C Radio and Tv Ltd.
- (2) This Order expires three years from the date of publication.
