## CUSTOMS DUTIES AND CONSUMPTION TAX (CLIFF'S BUS SERVICE INC.) (EXEMPTION) ORDER

THE CUSTOMS DUTIES AND CONSUMPTION TAX (CLIFF'S BUS SERVICE INC.) (EXEMPTION) ORDER 2016 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOM DUTIES AND CONSUMPTION TAX ACT (CAP.17.05).

#### 1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Cliff's Bus Service Inc.) (Exemption) Order, 2016.

#### 2. Exemption

Cliff's Bus Service Inc., is exempted from the payment of customs duty and consumption tax on the importation of the items listed in the Schedule.

#### 3. Condition

The exemption under Paragraph 2 is valid for a period of three months from 1 June, 2016.
