**THE CUSTOMS DUTIES AND CONSUMPTION TAX (EURLIN JEFFERS) (EXEMPTION) ORDER 2014 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 17(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).**

**1. Citation**

This Order may be cited as the Customs Duties and Consumption Tax (Eurlin Jeffers) (Exemption) Order, 2014.

**2. Exemption**

Eurlin Jeffers is exempted from the payment of customs duty and consumption tax on the importation of—

- (a) a CTC-30 countertop cooler;
- (b) a three tiered wire display stand;
- (c) a portable compact refrigerator freezer;
- (d) a Waring Commercial WDM120 heavy duty diecast drink mixer;
- (e) a Popheaven Commercial twelve ounce popcorn popper machine;
- (f) a R10-H-68 icecream display freezer;
- (g) two pieces squivel elegant PU leather modern adjustable bar stool chair;
- (h) an Acrylic Lucite counter top display case; and
