THE CUSTOMS DUTIES AND CONSUMPTION TAX (GENESIS STEEL ORCHESTRA) (EXEMPTION) ORDER 2018 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Genesis Steel Orchestra) (Exemption) Order, 2018.

2. Exemption

Genesis Steel Orchestra is exempted from the payment of Customs Duty and Consumption Tax on the importation, within one year from the commencement of this Order, of the items set out in the Schedule.
