1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Island Solutions) (Exemption) Order, 2018.

2. Exemption

Andrew Myers, trading as Island Solutions, is exempted from the payment of Customs Duty and Consumption Tax on the importation of the items set out in the Schedule.
