THE CUSTOMS DUTIES AND CONSUMPTION TAX (SYLVESTER SOLOMON) (EXEMPTION) (NO. 2) ORDER 2015 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOM DUTIES AND CONSUMPTION TAX ACT (CAP.17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Sylvester Solomon) (Exemption) (No. 2) Order, 2015.

2. Exemption

Sylvester Solomon, trading as Bamboo Grill Restaurant, is exempted from the payment of customs duty and consumption tax on the importation of the items listed in the Schedule at a maximum value of US\$50,000.

3. Condition

The exemption under paragraph 2 is valid for a period of eighteen months after the commencement of this Order.

4. Repeal

The Customs Duties and Consumption Tax (Sylvester Solomon) (Exemption) Order, 2015 (S.R.O No. 12 of 2015) is repealed.
