### CUSTOMS DUTIES AND CONSUMPTION TAX (REDUCTION OF CUSTOMS DUTIES AND CONSUMPTION TAX) (CHRISTMAS BARRELS) ORDER

THE CUSTOMS DUTIES AND CONSUMPTION TAX (REDUCTION OF CUSTOMS DUTIES AND CONSUMPTION TAX) (CHRISTMAS BARRELS) ORDER 2017 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(1) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

## 1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Reduction of Customs Duties and Consumption Tax) (Christmas Barrels) Order, 2017.

#### 2. Reduction of Customs Duties and Consumption Tax

Subject to paragraph 3, customs duties and consumption tax payable on a barrel is reduced to \$50.

## 3. Conditions

- (1) The reduction of customs duties and consumption tax under paragraph 2 is—
  - (*a*) applicable to a barrel imported into Montserrat from 1 November, 2017 to 6 January, 2018;
  - (b) on a maximum of two barrels for each household.
- (2) A barrel does not qualify for the reduction in customs duties and consumption tax under paragraph 2 if the barrel contains commercial items or items for resale, car parts, electrical items, electronics or more than 40 oz. of alcohol.
- (3) An applicant shall complete the declaration form under the Schedule.
