**1. Citation**

This Order may be cited as the Customs Duties and Consumption Tax (Joan Weekes) (Exemption) Order, 2015.

**2. Exemption**

Joan Weekes trading as Unique Touch Salon & Spa is exempted from the payment of customs duty and consumption tax on the importation of the items listed in the Schedule at a total cost of US\$927.
