**THE CUSTOMS DUTIES AND CONSUMPTION TAX (DAGRIE WILSON) (EXEMPTION) ORDER 2015 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).**

**1. Citation**

This Order may be cited as the Customs Duties and Consumption Tax (Dagrie Wilson) (Exemption) Order, 2015.

**2. Exemption**

Dagrie Wilson trading as Beauty Plus is exempted from the payment of customs duties and consumption tax on the importation of the items listed in the Schedule.
