MATRIMONIAL PROCEEDINGS (FEES) ORDER

THE MATRIMONIAL PROCEEDINGS (FEES) ORDER, 2014 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 22 OF THE MATRIMONIAL PROCEEDINGS ACT, 2012 (NO. 16 OF 2012).

1. Citation

This Order may be cited as the Matrimonial Proceedings (Fees) Order, 2014.

2. Fees

The fees listed in the Schedule are payable for matrimonial proceedings in accordance with the Matrimonial Proceedings Act 2012.

3. Fees to be taken in stamps

The Registrar of the High Court shall receive the fees set out in the Schedule in stamps denoting the amounts payable.

4. Repeal

The High Court (Fees in Matrimonial Proceedings) Order 1973 (SRO 38 of 1973) is repealed.
