THE PUBLIC HEALTH (COVID-19 SUPPRESSION) (NO. 6) (AMENDMENT) (NO.2) ORDER 2020 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 10 OF THE PUBLIC HEALTH ACT (CAP. 14.01).

1. Citation

This Order may be cited as the Public Health (Covid-19 Suppression) (No. 6) (Amendment) (No.2) Order, 2020 and comes into force 12:01 a.m. on 26 December, 2020.

2. Interpretation

In this Order, “**principal Order**” means the Public Health (COVID-19 Suppression) (No. 6) Order, 2020 (SRO. 80 of 2020).

3. Paragraph 7 amended

Paragraph 7 of the principal Order is amended by inserting the following as subparagraph (4)—

“(4) Despite subparagraph (1), the Minister may by notice restrict the category of persons who may enter Montserrat.”.

4. Paragraph 10 amended

Paragraph 10 of the Principal Order is amended by deleting subparagraph (3) and inserting the following—

“(3) A person who is staying at a designated quarantine facility shall comply with any rule or guideline issued by the Minister.”.

5. Paragraph 11 amended

Paragraph 11 of the principal Order is amended by deleting paragraph (3)(a) and inserting the following—

“(a) fourteen days has elapsed;”.

6. Paragraph 29 deleted

Paragraph 29 of the principal Order is deleted and the following is substituted—
