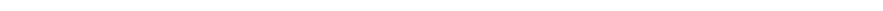

**THE CUSTOMS DUTIES AND CONSUMPTION TAX (PHOENIX GROUP INTERNATIONAL LTD.) (EXEMPTION) ORDER 2021 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).**

**1. Citation**

This Order may be cited as the Customs Duties and Consumption Tax (Phoenix Group International Ltd.) (Exemption) Order, 2021.

**2. Exemption**

Phoenix Group International Ltd. is exempted from the payment of Customs Duty and Consumption Tax on the importation of the items described in the Schedule, from the date of the grant of planning permission in accordance with the Physical Planning Act (Cap. 8.03).

**3. Expiry**

The exemption expires three years after the grant of planning permission referred to under paragraph 2.
