AN ACT TO PROVIDE FOR AN AMENDMENT TO THE SCHEDULE OF THE APPROPRIATION ACT 2016 (NO.3 OF 2016)

APPROPRIATION (AMENDMENT OF SCHEDULE) BILL, 2016

OBJECTS AND REASONS

The object of this Bill is to amend the Schedule to the Appropriation Act 2016 (No.3 of 2016) to give effect to a transfer of a total of \$5,500,400 from the Ministry of Communications, Works and Labour to the Office of the Premier as follows:

- (a) \$20,500 under Development Fund Votes for a project to finalise online booking services for ferry operations; and
- (b) \$5,479, 900 under Supply Votes for salaries, subsidies and other operational costs.

The amounts allocated to these services are enumerated in the Schedule thereto.

The transfer does not affect or supplement the total sum of \$165,868,100 appropriated for the services of Montserrat for the year ending 31st March, 2017 under the Appropriation Act 2016 (No. 3 of 2016).
