

MONTSERRAT TRAVEL PROTOCOLS

PRE-TRAVEL REQUIREMENTS



1 CONFIRM ACCOMMODATION

Ensure that you have confirmed where you will stay while on Montserrat.

2 TRAVEL TO MONTSERRAT

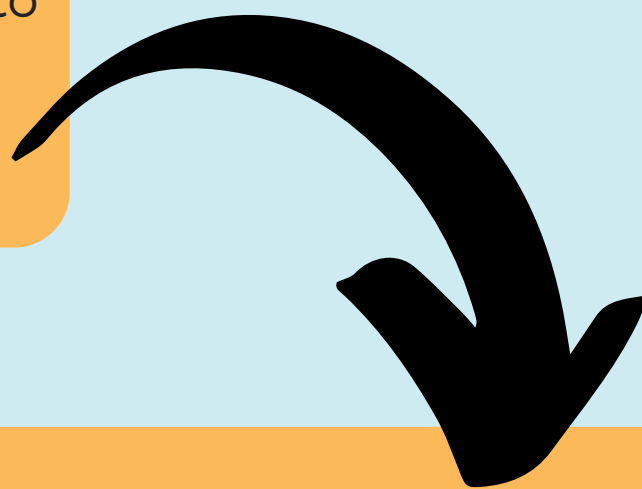
Air Travel provided by Fly Montserrat and SVG Air.

3 COVID-19 TEST CONDUCTED ON ARRIVAL

As of July 11, 2022 all persons will be required to take a COVID-19 Test on entry; regardless of vaccination status.

Note: You **do not** need to pay for your on-arrival COVID-19 Test.



QUARANTINE REQUIRED FOR POSITIVE PERSONS

If your on-arrival COVID-19 test returns a positive result, you will be required to self-quarantine for 10 days. After 10 days, you are allowed to leave quarantine and you are not required to be tested again for release.

This applies to **all** persons (vaccinated and unvaccinated)

General Travel Guidelines

- You do not need a negative COVID-19 test prior to travelling to Montserrat. However, please check the requirements for the ports/islands that you will travel through to get to Montserrat.
- You **do not** have to pay for the COVID-19 Test which will be conducted on arrival on Montserrat.
- If you require a COVID-19 Test when leaving/departing Montserrat, you will have to pay this cost. Please see the COVID-19 Test Fees on page 3.
- A child under the age of 18 years who enters Montserrat will be treated like the adult who accompanied the child to Montserrat.
- A child two years and under is not required to take a COVID-19 test.
- You do not need to register to travel to Montserrat.

COVID-19 TEST FEE EXEMPTIONS

The following persons do not have to pay for a COVID-19 Test:

1. A person who enters Montserrat by air or sea;
2. A person who is required to leave Montserrat on official Government business, once the person intends to return to Montserrat immediately after the completion of official Government business;
3. A person undertaking a course of study at an educational institution outside of Montserrat;
4. A person who is likely to be infected with COVID-19, as determined by a Health Officer
5. A person who is referred overseas for medical treatment;
6. A person under 18 years;
7. An official from an international or regional partner of the Government of Montserrat, who intends to visit Montserrat for official business;
8. A person who is over 70 years of age and is residing on Montserrat, and
9. A pilot who navigates a flight into Montserrat on a habitual basis.
