## Overview

---

The Ministry of Agriculture, Lands, Housing & the Environment is inviting Expressions of Interest from suitably qualified candidates to serve as members of the Electrical Licensing Authority in accordance with the Electrical Installations Act CAP 8.15. Section 3 (1) of the Act provides for the appointment of two representatives of civil society to be appointed by the Governor, acting on the advice of Cabinet. The members shall be appointed for a period of two years and are eligible for re-appointment. Members must not engage in any duties which may be conflicting to the work of the Authority.

In an effort to afford a more transparent selection of members who serve on the Authority, we are inviting Expressions of Interest who wish to be considered for inclusion on the Authority body. The successful candidates will be selected following an assessment based on the qualifications and experience outlined below. The individuals designated will perform their duties professionally and ethically, in accordance with the functions of the Authority. Applicants are expected to declare any (real or perceived) conflict of interest on application.

## Background

---

The Electrical Licensing Authority is constituted under the Electrical Installation Act CAP 8.15 Sections 1 to 4. The Functions of the Authority include:

- i. The power to grant an electrical license for either the Electrical Contractor/Wireman under the Act.
- ii. The power to revoke a license.
- iii. The power to seek information on electrical conduct via illegal wiring etc. non-compliance.

## **Qualifications and Experience**

---

The Ministry of Agriculture, Lands, Housing & the Environment is seeking individuals who possess:

- i. At least five (5) years' practicing as a licensed wireman or contractor on Montserrat.
- ii. Must possess appropriate qualifications and experience in electrical installation practise or equivalent qualification.
- iii. Has knowledge of the electrical laws of Montserrat.
- iv. Ability to communicate effectively; verbally and in writing.
- vi. Holds a City and Guilds Certification (Electrical installation) or any closely related field.
