THE CUSTOMS DUTIES AND CONSUMPTION TAX (CYNTHIA BOLDEN) (EXEMPTION) ORDER 2023 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

#### 1. Citation
