**PASSENGER FARES REGULATIONS**

**THE PASSENGER FARES REGULATIONS 2023 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 78(1) OF THE ROAD TRAFFIC ACT (CAP. 7.06).**

**1. Citation**

These Regulations may be cited as the Passenger Fares Regulations, 2023.

**2. Interpretation**

In these Regulations—

“**daytime**” means the period of time commencing at 5a.m. and ending at 7p.m.;

“**night-time**” means the period of time between 7p.m. to 5a.m.;

“**taxicab**” means a public service vehicle other than a motor omnibus.

**3. Fares and routes to be exhibited in motor omnibuses**

- (1) The driver of any motor omnibus shall exhibit in a conspicuous place inside the motor omnibus a legible notice specifying—
  - (a) the route of the motor omnibus and the corresponding fare; and
  - (b) the number of passengers which the motor omnibus is licenced to carry.
- (2) A person who contravenes subregulation (1) commits an offence.

**4. Fares to be exhibited in taxicabs and motor vehicles used for tours**

- (1) The driver of a taxicab or a motor vehicle used to conduct tours shall exhibit in a conspicuous place inside the taxicab or motor vehicle used to conduct tours a legible notice specifying the fares.
- (2) A person who contravenes subregulation (1) commits an offence.

- (2) The maximum fare to be charged for distances not listed in subregulation (1) is EC\$15 or US\$5.
- (3) An additional charge of 25 percent of a fare in subregulation (1) is payable for a taxicab during the night-time hours.

**6. Fares for tours**

- (1) The following fares are the maximum fares chargeable per hour for tours—

- (2) The fares chargeable for tours conducted in less than one hour shall not exceed the fares set out in subregulation (1).
- (3) The fare chargeable per hour under subregulation (1) shall be determined based on the number of passenger seats in the motor vehicle and shall not be increased, despite the number of passengers occupying the motor vehicle.
- (4) Despite this regulation, a special package tour may be arranged and the fare for the special package tour shall be agreed in advance with the persons attending the tour.

**7. Fares for motor omnibuses**

- (1) The following fares are the maximum fares chargeable per person in respect of motor omnibuses for the corresponding routes, during the daytime—

- (2) A child aged 12 years or under shall pay half of the fare set out in subregulation (1).
- (3) An additional fare of EC\$3 is payable for a journey and stop not included in a route under subregulation (1).
- (4) Despite this regulation, a fare of EC\$7 is payable for a journey and stop during the night-time.

**8. Repeal**

The Passenger Fares Regulations (SRO 70 of 2005) is repealed.
