**1. Citation**

This Order may be cited as the Eastern Caribbean Asset Management Corporation Act (Amendment of Schedule) Order 2023.

**2. Schedule amended**

The Agreement in the Schedule to the Eastern Caribbean Asset Management Corporation Act (Cap. 11.34) is amended—

- (a) in Article 10(6), by deleting “fifty-one months” and substituting “six years”; and
- (b) in Article 66, by deleting paragraph (1) and substituting the following—

“(1) A director may hold office for a term not exceeding three years and is eligible for re-appointment for a further two terms, each term not exceeding three years.”.
