**THE CUSTOMS DUTIES AND CONSUMPTION TAX (CAROL TUITT) (EXEMPTION) ORDER 2023 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).**

**1. Citation**

This Order may be cited as the Customs Duties and Consumption Tax (Carol Tuitt) (Exemption) Order, 2023.

**2. Exemption**

Carol Tuitt is exempted from the payment of Customs Duty and Consumption Tax on the importation of the items described in the Schedule.

**3. Condition**

The following conditions apply to the exemption granted in paragraph 2—

- (a) the items exempted shall only be used on the property registered to Carol Tuitt and located at Jones Hill; and
- (b) Carol Tuitt shall keep a record which details how the items exempted under paragraph 2 are used and shall provide upon request a copy of the record to the Comptroller of Customs or a Customs Officer.

**4. Expiry**

This order expires 31 December, 2024.
