ADVCE OF CABINET UNDER SECTION 3 OF THE BURIAL
GROUNDS ACT (CAP. 14.12).**

**A PROCLAMATION BY THE GOVERNOR ACTING ON THE
ADVICE OF CABINET

WHEREAS under section 3 of the Burial Grounds Act (Cap. 14.12), the Governor acting on the advice of Cabinet may by proclamation licence as a public or private burial ground any parcel of land which may be required for that purpose;

AND WHEREAS the Governor acting on the advice of Cabinet has designated a part of Block 14/07 Parcel 53 for use as a public burial ground;

NOW THEREFORE, I, SARAH TUCKER, Governor acting on the advice of Cabinet hereby licence as a public burial ground the area of land outlined in the map set out in the Schedule and labelled as ‘Private Burial Ground’ and described as follows:

A part of Block 14/7 Parcel 53 in the St. John’s Registration Section, situated at Lookout, such part being comprised of approximately 2.89 acres and bounded as follows—

- (a) On the North by a Utility Corridor and Block 14/8 Parcel 01 in the St. John’s Registration Section, known as the Lookout Public Cemetery;

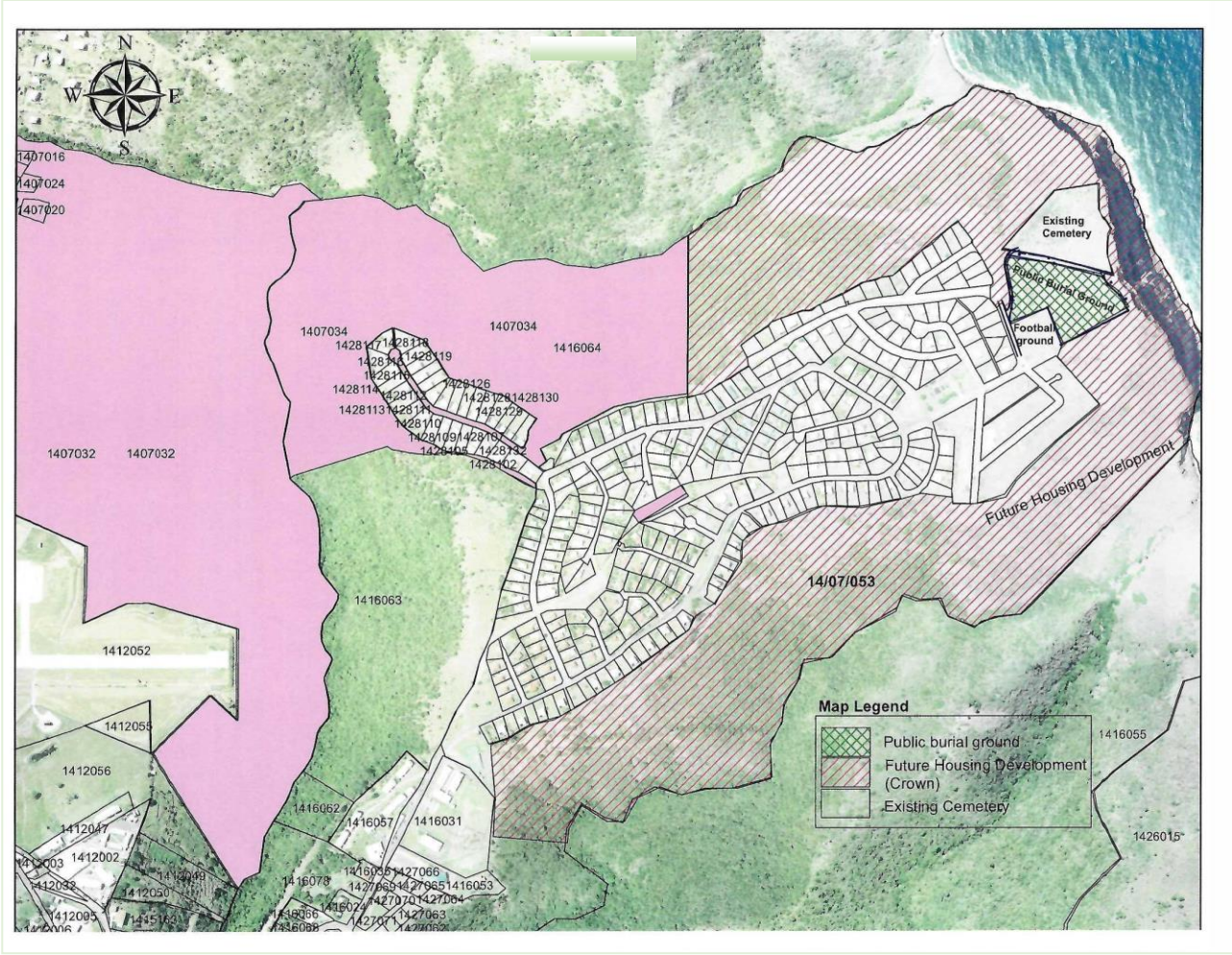
- (b) on the East by a Utility Corridor and part of Block 14/7 Parcel 53 in the St. John's Registration Section;
- (c) on the South partly by Block 14/8 Parcel 002 and known as the Lookout Football Field and partly by a Road Reserve and part of Block 14/7 Parcel 53 in the St. John's Registration Section;
and
- (d) on the West partly by Block 14/8 Parcel 002 in the St. John's Registration Section and known as the Lookout Football Field.

AND all His Majesty's Officers and loving subjects in Montserrat, and all those whom it may concern are hereby required to take due notice and conduct themselves accordingly.
