**RESOLUTION OF THE LEGISLATIVE ASSEMBLY TO WRITE OFF PUBLIC MONEY**

**MADE UNDER SECTION 54 OF THE PUBLIC FINANCE (MANAGEMENT AND ACCOUNTABILITY) ACT (CAP. 17.07).**

**WHEREAS** section 54(1) of the Public Finance (Management and Accountability) Act (CAP. 17.07) (“the Act”) provides that the Legislative Assembly may by resolution authorise the Minister of Finance to abandon and remit any claims by or on behalf of the Government, or any service to government and write off losses of or deficiencies in public moneys or public resources;

**AND WHEREAS** section 54(2) of the Act provides that a resolution under section 54(1) of the Act may specify the maximum amount authorised for each write off or abandonment and the total sum authorised to be written off or abandoned in a financial year;

**AND WHEREAS** a request has been received from the Minister of Finance for the write off of arrears deemed uncollectible, amounting to \$21,222,737.30, and as specified in the Schedule;

**BE IT RESOLVED** that the Minister of Finance is authorised to write off arrears deemed uncollectible in the amount of \$21,222,737.30.
