**CUSTOMS DUTIES AND CONSUMPTION TAX
(CHRISTIANA HOWE) (EXEMPTION) ORDER**

THE CUSTOMS DUTIES AND CONSUMPTION TAX (CHRISTIANA HOWE) (EXEMPTION) ORDER 2024 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Christiana Howe) (Exemption) Order, 2024.

2. Exemption

Subject to paragraph 3, Christiana Howe is exempted from the payment of Customs Duty on the importation of the items described in the Schedule.

3. Conditions

The exemption referred to in paragraph 2 only applies if the items are—

- (a) imported by and addressed to Christiana Howe; and
- (b) used by Christiana Howe on her property located at Block 14/15 Parcel 180.

4. Record keeping

- (1) Christiana Howe shall keep a record of the items imported pursuant to paragraph 2 and shall produce the record to the Comptroller of Customs or a Customs Officer on the request of the Comptroller of Customs or a Customs Officer.

- (2) The record referred to in subparagraph (1) shall set out how each item is being used on the property located at Block 14/15 Parcel 180.

5. Expiry

This Order expires 1 March 2025.
