AN ORDINANCE TO PROVIDE FOR THE RAISING OF A LOAN FROM BARCLAYS BANK INTERNATIONAL LIMITED FOR THE PURPOSE OF PURCHASING AND MARKETING THE 1974-1975 COTTON CROP IN MONTSERRAT, TO PROVIDE FOR THE REPAYMENT OF THE LOAN, AND FOR PURPOSES INCIDENTAL THERETO OR CONNECTED THEREWITH.

Commencement.

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council of Montserrat and by the authority of the same as follows:-

1. This Ordinance may be cited as the Cotton Purchasing and Marketing (1974-1975 Cotton Crop) Loan (Barclays Bank International Limited) Ordinance, 1975, and shall be deemed to have come into force on the 1st day of March, 1975.

Short Title and Commencement.

2. In this Ordinance, -

Interpretation.

“the loan” means the loan authorized to be raised under this Ordinance;

“The Minister of Finance” means the member of the Executive Council of Montserrat responsible for the subject or department of Finance.

3. Subject to the provisions of this Ordinance, the Minister of Finance may from time to time borrow a sum or sums of money not exceeding in the aggregate Seventy-one thousand six hundred and forty dollars East Caribbean Currency by means of a Loan or Loans from Barclays Bank International Limited.

Power to borrow from Barclays Bank International Limited.

4.(1) Any loan raised under the provisions of this Ordinance shall be repaid with interest at the rate of 9 per

centum per annum or at such other rate as may be agreed upon between the Minister of Finance and Barclays Bank International Limited with the concurrence of a Secretary of State.

(2) The Principal sums together with interest thereon shall be repaid within a period of six months from the date of receipt of the loan or such longer period as may be agreed between the Minister of Finance and Barclays Bank International Limited.

Loan to be charged upon the Consolidated Fund of the Colony.

5. The Principal monies of any loans raised under the provisions of this Ordinance together with interest thereon shall be charged upon and payable out of the Consolidated Fund of the Colony without further appropriation by the Legislative Council of the Colony other than this Ordinance.

Application of Loan.

6. Any monies borrowed under the provisions of this Ordinance shall be appropriated and applied to the purpose of purchasing the 1974-1975 Cotton Crop and to the purpose of defraying the expenses of ginning and marketing the same.
