**THE CUSTOMS DUTIES AND CONSUMPTION TAX (VICTOR'S MONTSERRAT LIMITED) ORDER 2024 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).**

**1. Citation**

This Order may be cited as the Customs Duties and Consumption Tax (Victor's Montserrat Limited) (Exemption) Order, 2024.

**2. Exemption**

Victor's Montserrat Limited is exempted from the payment of Consumption Tax on the importation of the items described in the Schedule.

**3. Expiry**

This Order expires 31 January 2025.

**4. Repeal**

The Customs Duties and Consumption Tax (Victor's International Limited) (Exemption) Order, 2024 (SRO 13 of 2024) is repealed.
