**INTERPRETATION ACT (PUBLICATION OF SUBORDINATE  
LEGISLATION) ORDER MADE BY THE GOVERNOR ACTING  
ON THE ADVICE OF CABINET UNDER SECTION 68(1) OF THE  
INTERPRETATION ACT (CAP 01.02).**

**1. Citation**

This Order may be cited as the Interpretation Act (Publication of Subordinate Legislation) Order, 2024.

**2. Designation of Public Notice Board**

The public notice board at the entrance of the Office of the Legislature located at Farara Plaza in Brades is designated as the public notice board for the publication of subordinate legislation.

**3. Designation of Public Officer**

- (1) The Cabinet Secretary is the public officer responsible for the publication of subordinate legislation on the public notice board designated under paragraph 2.
- (2) If the Cabinet Secretary is on leave, ill or otherwise unable to perform the duties of Cabinet Secretary, the Permanent Secretary in the Office of the Premier shall act as Cabinet Secretary and while acting, has all the powers and duties of the Cabinet Secretary.

**4. Manner of publication**

The Cabinet Secretary shall—

- (a) sign and date a copy of the subordinate legislation to be published; and
- (b) on the date of signing, cause the signed subordinate legislation to be exhibited on the public notice board designated under paragraph 2.

**5. Length of Publication**

The subordinate legislation published under paragraph 4 must remain on the public notice board designated under paragraph 2 for as long as space on the public notice board permits.

**6. Repeal**

The Interpretation Act (Publication of Subordinate Legislation) Order 2015 (S.R.O No. 28 of 2015) is repealed.
