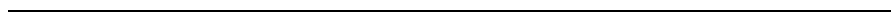

REVISED EDITION (PENAL CODE) (RECTIFICATION) ORDER

**THE REVISED EDITION (PENAL CODE) (RECTIFICATION) ORDER 2024
MADE BY THE ATTORNEY GENERAL UNDER SECTION 11 OF THE REVISED
EDITION OF THE LAWS ACT (CAP. 1.03).**

WHEREAS section 11 of the Revised Edition of the Laws Act (Cap. 1.03) gives the Attorney General the power to rectify any clerical, printing or other error found in any matter included in the revised edition of the Laws; and

WHEREAS the Revised Edition of the Laws Order, 2020 (S.R.O. 5 of 2020) brought the 2019 Revised Edition of the Laws of Montserrat into force on 15 February, 2020; and

WHEREAS the Penal Code (Cap. 4.02) forms part of the 2019 Revised Edition of the Laws of Montserrat; and

WHEREAS after the 2019 Revised Edition of the Laws of Montserrat was brought into force on 15 February, 2020 the Attorney General found that the Penal Code (Cap. 4.02) contained a clerical, printing or other error;

NOW THEREFORE the Attorney General makes the following Order:

1. Citation

This Order may be cited as the Revised Edition (Penal Code) (Rectification) Order, 2024.

2. Interpretation

In this Order, “**principal Act**” means the Penal Code (Cap. 4.02).

3. Section 110 rectified

Section 110 of the principal Act is rectified by deleting paragraph (c) and substituting the following—

“(c) obstructs or in any way interferes with or knowingly prevents the execution of any legal process, civil or criminal.”
