**1. Citation**

This Order may be cited as the Customs Duties and Consumption Tax (Ducketts Montserrat Ltd.) (Exemption) Order, 2025.

**2. Exemption**

Ducketts Montserrat Ltd. is exempted from the payment of Customs Duty and Consumption Tax on the importation of the items set out in the Schedule.
