**PUBLIC HOSPITAL (AMENDMENT) (NO. 2) REGULATIONS 2026
MADE BY THE GOVERNOR ACTING ON THE ADVICE OF
CABINET UNDER SECTION 8 OF THE PUBLIC HEALTH ACT (CAP.
14.01).**

1. Citation

This Order may be cited as the Public Hospital (Amendment) (No. 2) Regulations, 2026.

2. Regulation 5 amended

Regulation 5 of the Public Hospital Regulations (Cap. 14.01) is amended by deleting subregulation (3) and substituting the following—

- “(3) The fees specified in the Schedule apply to a person who is a Montserratian.
- (4) A non-Montserratian shall pay two times the rate set out in the Schedule.
- (5) Despite subregulations (3) and (4), the following persons shall pay the same fees as a Montserratian—
 - (i) a citizen of a member state of the Caribbean Community who has resided in Montserrat for 3 years or more;
 - (ii) a citizen of the Dominican Republic who has resided in Montserrat for 3 years or more; and
 - (iii) a person who is a resident of the United Kingdom and who has a British National Health Service Medical Card in his name.”.

3. Regulation 7A inserted

The Public Hospital Regulations (Cap. 14.01) is amended by inserting the following as regulation 7A—

“7A. Treatment of a child without charge

Despite anything in these Regulations, a child is entitled to access healthcare services free of charge.”.

4. Regulation 8 amended

Regulation 8.A.(3)(b) of the Public Hospital Regulations (Cap. 14.01) is deleted.

5. Schedule of Fees amended

The Schedule of the Public Hospital Regulations (Cap. 14.01) is amended by deleting the preamble which appears after “PART 1”.

6. Revocation

The Public Hospital (Amendment) Regulations, 2026 (SRO 1 of 2026) is revoked.
