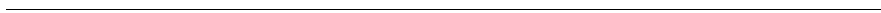

THE CUSTOMS DUTIES AND CONSUMPTION TAX (PATRICIA FARRELL-DAWAY) (EXEMPTION) ORDER 2026 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Patricia Farrell-Daway) (Exemption) Order, 2026.

2. Exemption

Patricia Farrell-Daway trading as Patsy's Cake Baking and Decorating, is exempted from the payment of Customs Duty on the items listed in the Schedule.

3. Expiration

This Order expires on 21 January 2027.
